SUBJECT: Request for Special Retirement Coverage for Firefighter Position

Request the attached standard core personnel document (SCPD) be covered under the special retirement provisions for firefighters. This coverage is requested for the Civil Service Retirement System (CSRS) IAW 5 USC 8336(c) and the Federal Employees' Retirement System (FERS) IAW 5 USC 8412(d). Coverage of these positions will help us "bridge the gap" between any discrepancies we have between CSRS and FERS firefighter positions. It will also adjust coverage determinations due to changes in the classification of firefighter positions when the current standard was updated in September 1991. In our opinion, position SCPD# 8004750, Firefighter (Emergency Medical Technician), GS-0081-06, dated 23 January 2002, should be covered as primary/rigorous.
