## Tax Season is Here

Tax season is here, and we want to make sure that you are prepared. Now is the best time to verify everything is correct in your myPay account so you can retrieve your tax documents when you need to file.

### Start with myPay

The best tool DFAS offers to ensure a smooth tax season is myPay (<https://mypay.dfas.mil>). The most important step to take is to log in to your myPay account and ensure your mailing address is correct.

An easy, online stop for your tax season needs, myPay offers printing or downloading of your tax statements for your retired pay. You can download and print your current year tax statement, as well as prior year 1099Rs (up to four prior years for retirees). If you have them, you can also download and print IRS form 1095B.

You will have earlier access to your tax documents through myPay; 1099Rs are generally available in myPay in late December, while paper copies are mailed in mid-to-late January. If you haven't logged in to myPay recently, this is a good time to log in and update your password before the busy tax season.

### Changing Federal Tax Withholding

It's easy to review your current federal withholding status in myPay. If needed, you may adjust it through the corresponding menu option or view withholding amounts on your latest Retiree Account Statement (RAS). The form can be found on our website at <https://www.dfas.mil/raforms>.

### Use the IRS Tax Withholding

### Estimator

The Internal Revenue Service (IRS) has an online Tax Withholding Estimator to help you determine how much tax you need to have withheld. The calculator helps taxpayers estimate if the right amount is withheld from their income to cover their tax liability. The estimator uses a simple, six-step question-and-answer format using information like marital or filing status, income, withholding, adjustments, deductions, and credits. ### State Taxes for Retirees

Retirees can start, stop, or change their State Income Tax Withholding (SITW), but only if that state has an agreement in place allowing DFAS to withhold state tax. In some states, portions of your retired pay may be tax exempt. Because tax obligations vary from state to state, contact your state's department of revenue regarding taxability of your military retired pay.

Any changes to SITW must be made in writing, by submitting a DD 2866 form or by using myPay. DFAS can only withhold income tax for one state at a time, and the designated state must have signed the standard written SITW agreement with the Department of Defense (DoD). ### Federal Taxability of Retired Pay

Military retired pay is paid for many different reasons under many different laws. There are differences in the types of pay a military retiree might receive and the tax laws that apply to them. Whether a portion or all of an individual's military retired pay is subject to federal income taxes depends on his/her individual circumstances.

A military retiree can either use myPay or send an IRS Form W-4 to alter the amount DFAS withholds for federal income taxes from their military retired pay. An individual's choice to have no withholding for federal taxes does not

impact whether the individual's military retired pay is actually subject to federal income tax. Ultimately, the IRS will determine the amount of taxes owed on military retired pay.

**Please note:** *The IRS requires any individual claiming exemption from federal withholding to provide a new IRS Form W-4 at the beginning of each tax year certifying their exemption from withholding. Please see our webpage regarding taxation of retired pay: <https://www.dfas.mil/retpaytax>.*

## Gray Area Retiree Spotlight: Check Your Contact Information

We want to continue communicating with our Gray Area Retiree (GAR) customers. In the next few months, we will send a SmartDoc email to remind GARs to keep their contact information up to date.

The SmartDoc email will be sent to GARs that have a "Future Retiree" myPay account and will explain how to update your email address, mobile number, and mailing address. Contact information should be updated with DFAS, DEERS, and your Branch of Service.

DFAS recommends you check your myPay account at least once a year to ensure we have your current contact information. Having your mobile number added to your myPay account, you can receive

temporary passwords and important text messages related to your myPay account, if you choose to enable these text notifications.

The SmartDoc email will also ask for your help to spread the word so other GARs know about setting up a "Future Retiree" myPay account and accessing our dedicated GAR webpage at <https://www.dfas.mil/grayarea>. On this webpage, GARs can refer to our helpful downloadable "Gray Area Future Retiree myPay Login Tips" to log into their myPay account and see their Branch of Service-specific GAR webpage where they can get information from their Branch of Service about how to apply for retired pay.

# OPM Implements Two-Page Resume Standard to Streamline Federal Hiring

The U.S. Office of Personnel Management (OPM), in collaboration with the Assistant to the President for Domestic Policy, today sent a comprehensive Frequently Asked Questions (FAQ) document to agencies to help support the implementation of the Merit Hiring Plan, pursuant to President Trump's Executive Order 14170. The FAQ provides detailed guidance to federal agencies on reforming the hiring process to prioritize merit and fairness. A key highlight of the Merit Hiring Plan is the introduction of a two-page resume limit for federal job applications submitted through USAJOBS that took effect September 27, 2025. This reform ensures hiring managers focus on the most relevant qualifications and experience, streamlining the review process. OPM is providing updated [USAJOBS](#) guidance and resume-building tools online to assist applicants in meeting the new standard. ## Foreign Government Employment

Foreign government employment (FGE) is defined as any civil employment with a foreign government agency or instrumentality of the foreign government whether or not compensation is received.

Applicants must receive approval from the Service Department and the Department of State **before** starting work in order to avoid forfeiting retirement pay or incurring debt. Due to the numerous agencies involved in the process, the processing timeline is lengthy and can take upwards of 12-18 months depending on circumstances.

## VA Insurance and the Accelerated Benefit Option

VA has announced an amendment to the Servicemember's Group Life Insurance (SGLI), Family SGLI (FSGLI), and Veterans' Group Life Insurance (VGLI) Accelerated Benefit Option (ABO) regulation.

This update allows an alternate applicant to apply for an ABO on a member's behalf, such as when a member is medically incapacitated. With accelerated benefits, you can get up to 50% of the face value of your coverage in increments of \$5,000—paid to you before death.

This change:

- Allows an alternate applicant to apply for the ABO on behalf of a medically incapacitated, terminally ill member.
- Authorizes a member to apply for the ABO when their insured spouse is terminally ill.
- Ensures stepchildren and children, who are 18-22 and in school, are included in FSGLI dependent child coverage.

This change comes as an update to the ABO that's been in effect since 1998 when only the member could apply. Click [here](#) to learn more.

## Air Force Families Forever: Survivor Advocacy Council

The Air Force Families Forever (AFFF) program serves as a conduit to personalized referrals and targeted information as it relates to the death of an Airman or Guardian and facilitates connection between survivors and the Department of the Air Force (if desired). AFFF ensures fallen Airmen, Guardians, and their families are always remembered by facilitating long-term case management to surviving family members of deceased Regular Air Force, U.S. Space Force, and Air Reserve Component Airmen and Guardians who died in an Active Duty, Inactive Duty for Training, or Annual Training status and whose relationship was established prior to the Airman/Guardian's death. Specific procedures are devised to provide support to eligible Next-of-Kin (NOK) through Military & Family Readiness Centers at the installation closest to where the survivor resides. AFFF program partners with the Tragedy Assistance Program for Survivors (TAPS), through a national memorandum of understanding, to offer grief counseling and connect DAF survivors with TAPS' myriad resources as well as participate in several TAPS' regional outreach events throughout the year.

AFFF also supports the Survivor Advisory Council (SAC) which serves as a senior forum for the Department of the Air Force (DAF) to obtain direct feedback from the survivor population and further the policies, programs, and support for surviving family members. Its objective is to champion survivor programs, recap key initiatives and next steps, secure vectors to strengthen support to DAF survivors, and validate their ongoing role in the larger DAF family. The SAC consists of 12 survivor representatives and one survivor mentor who are selected to serve a two-year term. The SAC representatives meet quarterly with senior leaders and subject matter experts from Casualty, Mortuary, and AFFF to work actions that improve the continuum of care for survivors and advocate on behalf of the broader survivor community. Their charter is to coordinate, establish and staff an office on an active-duty, Reserve or Guard base through command channels to help retirees and surviving spouses with a myriad of actions. These actions include: serving as an information center for TRICARE, base services, etc.; offering referrals for financial assistance and pay matters; counseling active-duty Airmen/Guardians nearing retirement; and providing guidance on retirement issues.

Another major activity involves working with base agencies to set up Retiree Appreciation Day events, offering briefings by different agencies on respective services, tax preparation and advice (at selected locations); staff judge advocate assistance, base tours, and more.
